# IDCOL & SREDA SIGNED AGREEMENT UNDER GCF

IDCOL and SREDA are collaborating to create a better environment for implementing energy efficiency measures in Bangladesh, with USD 1.13 million TA support from the Green Climate Fund (GCF). An agreement was signed in this regard on October 10, 2023.

### IDCOL SIGNED LOAN AGREEMENT WITH BSRM STEELS LIMITED (BSRMSL)

### IDCOL HAS EXTENDED SIGNIFICANT FINANCING TO SIRAJGANJ ECONOMIC ZONE LIMITED (SEZL)

IDCOL has extended significant financing to Sirajganj Economic Zone Limited (SEZL) for the development of a 1035 acres Economic Zone, marking the largest private economic zone in Bangladesh. IDCOL's approval of BDT 1725 million in debt financing demonstrates its commitment to supporting large-scale infrastructure projects in the private sector.
